### ERASMUS+ QUALITY FRAMEWORK

- Erasmus Charter for Higher Education for Partner countries, the principles of the Charter are embedded in the inter-institutional agreement
- Mobility Consortium Certificate
- Inter-institutional agreement to set mobility flows & preconditions (signed before mobility starts)
- Learning agreement for students
- Erasmus Student Charter highlights the rights and obligations of students participating in Erasmus+

Key Action 1 – Mobility for learners and staff – Higher Education Student and Staff Mobility

Inter-institutional<sup>1</sup> agreement 2014-20[21]<sup>2</sup> between programme countries
